


Chinese Church in London (CCiL) Croydon Chinese School COVID19 Risk Assessment

CCiL Risk Assessment Record

The assessor can assign values for the 'hazard severity' and 'likelihood of occurrence' on scales of 1-5 to aid with rating risks:

Hazard Severity (a)	Likelihood of Occurrence (b)
 1 – Trivial (e.g. discomfort, scratch, slight bruising) 2 – Minor (e.g. small cut, abrasion, basic first aid need) 3 – Moderate (e.g. strain, sprain, incapacitation > 3days) 4 – Serious (e.g. fracture, hospitalisation > 24 hrs, some loss, moderately affect name & reputation of the church) 5 – Fatal (death, severe loss, definitely affect name & reputation of the church) 	 1 – Remote (almost never) 2 – Unlikely (occurs rarely) 3 – Possible (could occur, but uncommon) 4 – Likely (recurrent, but not frequent) 5 – Very likely (occurs frequently)

The Risk Matrix showing risk rating (high, medium or low) indicates the response to be taken for the assessed risks.

Overview of activity / location / equipment / conditions being assessed:
Risks associated with Covid19.
Context of the assessment:
Following the outbreak of Covid19 pandemic, Chinese school has moved to online teaching. With the ease of lockdown, and reopening of primary and secondary school, we are preparing for returning to classroom teaching. This document is prepared to assess the risks that school staff, pupils, and parents are exposed to when attending or accompanying their children to school. Mitigation measures are outlined to reduce the risks.
This risk assessment is prepared based on the government Guidance for Protective measures for holiday and after-school clubs, and other out-of-school settings during the coronavirus (COVID-19) outbreak. Since the Chinese School includes classes using the school building of Archbishop Tenison's CE High School (ATS), the government Guidance for full opening: schools is also observed.
