 - If tax you paid is less than the Church reclaim, you are responsible for paying HMRC the difference.
- 3. If you pay tax at the higher rate, you can claim further tax relief in the self-assessment tax return.
- 4. If your circumstances change and/or no longer pay sufficient tax on your income and/or capital gains equal to the tax that the Church reclaims, you must cancel this declaration.
- 5. If you are unsure whether your donations qualify for Gift Aid tax relief, you may ask your congregational treasurer or the Church office or ask your local tax office.
- 6. Please notify the Church if you change your name or address.
- 7. I understand other taxes such as VAT and Council Tax do not qualify for gift aid purpose.
- 3. I understand the church will reclaim 25p of tax on every £1 that I give.
